#### **RESIGNATION**

1. Hollis Police Department

Chief Joseph Hoebeke, effective April 16, 2024 (last day in the office, March 29, 2024)

MOVED by Mark Le Doux seconded by Susan Benz that the Select Board regretfully accept the resignation of Joseph Hoebeke as Hollis Police Chief.

The Board members thanked the Chief for his service to the town and community and had many nice things to say about him as an individual and as a leader in the department. A formal ceremony will be held at the Lawrence Barn Community Center on March 28, 2024 at 3:30 PM.

Voting in favor of the motion was Petry, Benz, Le Doux, Whalen, and Garruba. No one was opposed. The motion PASSED 5-0-0.

#### **APPOINTMENTS**

1. Hollis Police Department

Captain Brendan LaFlamme, Interim Chief of Police, effective March 28, 2024 & Chief of Police, effective April 17, 2024

MOVED by Mark Le Doux seconded by Susan Benz that the Select Board approve the appointment of Brendan LaFlamme as Interim Chief of Police, effective March 28, 2024 and transitioning to Chief of Police, effective April 17, 2024.

B. LaFlamme thanked the Board for their support and trust in taking on the position. He thanked the town, community, family, friends, the department with a very special thank you to Chief Hoebeke.

Voting in favor of the motion was Petry, Benz, Le Doux, Whalen and Garruba. No one was opposed. The motion PASSED 5-0-0.

#### 2. Heritage Commission

Sharon McCaffrey, promoted to Regular Member, term to expire April 30, 2026

### 3. Deputy Forest Fire Warden, 3-year terms (Rob Boggis, Fire Chief) Lucas Bombardier; Samuel Cochrane; Beau Landry; Gordon Othot; and Michael Perault

The role of the Deputy Forest Fire Warden is to issue burn permits, issue warnings and enforcement. The Chief is the warden for the town, and the deputies work under the Chief. All deputies are currently employed with the town. The term is three years. The effective date will be when the Forest Ranger with the state signs the document. There are currently eight Deputy Forest Fire Wardens, made up of officers and full-time members of the Fire Department.

MOVED by Tom Whalen seconded by Joe Garruba that the Select Board approve Lucas Bombardier, Samual Cochrane, Beau Landry, Gordon Othot and Michael Perault as Deputy Forest Fire Warden's for the Town of Hollis. Voting in favor of the motion was Petry, Benz, Le Doux, Whalen and Garruba. No one was opposed. The motion PASSED 5-0-0.

#### **NEW BUSINESS**

#### 1. Town Meeting Update (Drew Mason, Town Moderator)

Preparations for town election and town meeting are underway. The presidential primary will be in September. Should anyone want to change their party affiliation, they should do so before June 5<sup>th</sup>. D. Mason has been monitoring the legislature and brought to the Board's attention, House Bill 154, House Bill 115 and Senate Bill 380.

#### 2. Emergency Management Committee (EMC) (Deane Navaroli, Emergency Management Director)

D. Navaroli provided an update to the Board, regarding the Inoperability Radio Project, stating that the project should wrap up by the end of April.

D. Navaroli requested the Select Board approve the formation of an Emergency Management Committee. Members would include representation from the Hollis Police Department, Hollis Fire Department, Hollis Communications Center, Hollis Department of Public Works and Hollis Town Administration (Administration, Planning, etc.).

 The committee will be limited to seven members (or fewer) plus an administrative assistant. It is anticipated that the committee will sunset on December 31, 2025 or upon successful completion of the defined projects and objectives. In the event an additional project arises prior to the sunset that warrants the continued involvement of the committee, an extension would be evaluated at that time.

MOVED by Susan Benz seconded by Tom Whalen that the Select Board approve the formation of an Emergency Management Committee for the Town of Hollis.

The committee shall formulate the Mission Statement and take into consideration the suggestions made by J. Garruba regarding the inclusion and primacy of the U.S. and New Hampshire Constitution and laws and statutes. Members of the committee shall include department heads or their designees.

Voting in favor of the motion was Petry, Benz, Le Doux, Whalen and Garruba. No one was opposed. The motion PASSED 5-0-0.

#### 3. Junior Firefighter Program (Rob Boggis, Fire Chief)

Chief Boggis explained that the program is currently affiliated with the Boys Scouts of America Exploring Program. It is requested that the Select Board not eliminate the program, but reaffiliate it under the Hollis Fire Department with the name, Junior Firefighter Program. The town's insurance carrier, Primex was contacted and reiterated that the program would need to be approved by the municipality and Fire Department in order to be covered under the town's insurance.

 MOVED by Susan Benz seconded by Tom Whalen that the Select Board disaffiliate the Fire Youth Program with the Boy Scouts of America and manage the program through the Hollis Fire Department under the name, Junior Firefighter Program. Voting in favor of the motion was Petry, Benz, Le Doux, Whalen and Garruba. No one was opposed. The motion PASSED 5-0-0.
