PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

AGENDA REVIEW

The Selectmen's agenda was reviewed.

ELECTION OF OFFICERS

MOVED by David Petry, seconded by Frank Cadwell that the Selectmen nominate Mark Le Doux as Chairman of the Board of Selectmen. Voting in favor of the motion were Petry and Cadwell. No one was opposed. Le Doux abstained. The motion PASSED 2-0-1.

MOVED by Mark Le Doux, seconded by Frank Cadwell that the Selectmen nominate David Petry as the Vice Chairman of the Board of Selectmen. Voting in favor of the motion were Le Doux and Cadwell. No one was opposed. Petry abstained. The motion PASSED 2-0-1.

NEW/OLD BUSINESS

1. Tax Collector - Execution of Tax Liens

MOVED by Frank Cadwell, seconded by David Petry that the Selectmen sign and approve the Affidavit of Execution of Real Estate Tax Lien, per RSA 80:61. Voting in favor of the motion were Le Doux, Petry and Cadwell. No one was opposed. The motion PASSED 3-0-0.

2. Selectmen Department and Committee Assignments

The Board agreed to remain with their respective department and committee assignments with a few modifications. F. Cadwell would like to represent the Department of Public Works (DPW) and have V. Manoukian as the alternate. He would also like to represent the Heritage Commission and have M. Le Doux as the alternate.

MOVED by David Petry, seconded by Frank Cadwell that the Selectmen approve the Department and Committee Assignments with the modification to include F. Cadwell as the DPW representative with V. Manoukian as the DPW alternate; and F. Cadwell as the Heritage Commission representative with M. Le Doux as the Heritage Commission alternate. Voting in favor of the motion were Le Doux, Petry and Cadwell. No one was opposed. The motion PASSED 3-0-0.

Chairman Le Doux noted that 32% of the land mass of the community is under conservation and that the Land Protection Study Committee (LPSC) has fulfilled their service to the town, at this time. M. Le Doux spoke with Paul Edmunds, LSCP Chairman, and suggested the commission retire following the completion of the Purchase and Sale Agreement for the Birch Hill Properties or by the end of this year. M. Le Doux stated that if there are any acquisitions of land or proposed conservation easements in the future, the Selectmen would obtain a committee of qualified experts to assist the Board in valuations and other proceedings. D. Petry and F. Cadwell were in concurrence of this arrangement.
