2017 Proposed Warrant Articles

Chairman Le Doux reviewed and explained all of the 2017 proposed Warrant Articles, noting that
funds from articles 3-6 and article 9 will come from the Undesignated Fund Balance as of
December 31, 2016, if available. The Board agree to remove the Article for Veterans Tax Credit
since there is also a Petition Article for Veteran's Tax Credit. The Board agreed to remove the
article to avoid confusion since both articles are identical in terms of scope and language. Article
10 - Petition Article for Veterans Tax Credit reads as follows:

- Shall the Town adopt the "all veterans' property tax credit" under RSA 72:28-b? If 31 adopted, the credit will be available to any resident, or the spouse or surviving spouse of 32 33 any resident, who (1) served not less than 90 days on active service in the armed forces of 34 the United States and was honorably discharged or was an officer honorably separated from service, and (2) is not eligible for and not receiving the credit for veterans who 35 served in a qualifying war or armed conflict or for veterans with a service-connected 36 37 disability. If adopted, the credit will be in the amount of \$500.00, which is the same amount as the credit for a veteran who served in a qualifying war or armed conflict. If 38 39 the credit is adopted, any person desiring to claim the credit will be required to file an application with the selectmen or the assessors by April 15 of the tax year. 40 41
 - MOVED by Frank Cadwell, seconded by Vahrij Manoukian that the Selectmen accept and recommend to the Budget Committee, Article 10 – Petition Article for Veterans Tax Credit, as written.
