COMMUNITY ROOM

9 Chairman Le Doux convened the April 13, 2015, Selectmen's meeting at 7:03 PM in the Town Hall Community Room.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

AGENDA REVIEW

Troy Brown reviewed the Selectmen's agenda.

PUBLIC COMMENT

Maryanne Shanley, Buttonwood Drive, announced that she reviewed the Brookline Board of Selectmen meeting minutes. It appears that the Brookline Selectmen are going to wait and see what happens in regards to the Cooperative School Study Committee being formed by the Hollis Board of Selectmen.

- Maryanne Shanley, Buttonwood Drive, contemplated saying nothing but felt that the Board of Selectmen was a bit hard on Elizabeth Brown at the last Selectmen's meeting. M. Shanley felt that E. Brown was just making suggestions and asking reasonable questions about the formation of the study committee. F. Cadwell felt the Board of Selectmen need to go into the process without deciding the outcome beforehand. F. Cadwell felt that E. Brown has already decided what the outcome of the study committee
- should be.

M. Le Doux gave an overview of the Annual Town meeting vote of the warrant article. The Board is going to go through the process they were directed to by the town meeting voters.

F. Cadwell stated that Hollis is in the process (through the newly formed committee) of determining its equity position in the Cooperative school system. In the end, if it is the best thing for Hollis to remain in the Cooperative School District, it will be great news. F. Cadwell felt that Brookline will be thrilled to receive all of the data that the newly formed committee will be able to provide.

5. Pole License – 62/5/ Pound Road

MOVED by Vahrij Manoukian, seconded by Frank Cadwell that the Selectmen approve the pole license #21-1179, dated 03/31/2015. Voting in favor of the motion were Le Doux, Petry, Cadwell, Band and Manoukian. No one was opposed. The motion PASSED 5-0-0.

1491506. Memorial Day

There will be a Memorial Day Celebration on the Town Common on Monday, May 25, 2015 at 5:00pm. The Lawrence Barn Community Center is the rain location. M. Le Doux will not be in Town on Memorial Day. Peter Band and Vahrij Manoukian were both in Town and agreed to attend the ceremony and provide opening and closing remarks.

7. Intent to Tax Property Owned by Others

MOVED by David Petry seconded by Vahrij Manoukian that the Selectmen sign and approve the Notice of Intent to Tax Personal Property on Land of Others per RSA 73:16-a, as presented. Voting in favor of the motion were Le Doux, Petry, Band, Cadwell and Manoukian. No one was opposed. The motion PASSED 5-0-0.

8. Memorandum of Understanding – William Hall Jr.

The Memorandum of Understanding (MOU) is signed each year between the Town of Hollis and William Hall, Jr. to allow timber cutting on Town property. The MOU has been approved by Attorney Drescher and the Forest Committee Chairman. The agreement has been in place for three or four years. The agreement is an annual agreement. The Board discussed if the conditions were satisfied. The Board asked the Town Administrator to make sure that the Intent to Cut had been properly executed.

MOVED by David Petry seconded by Frank Cadwell that the Selectmen approve and sign the Memorandum of Understanding by and between the Hollis Board of Selectmen and William Hall, Jr., as discussed. Voting in favor of the motion were Le Doux, Petry, Cadwell, Manoukian and Band. No one was opposed. The motion PASSED 5-0-0.

9. **2012** Tax Deeds

Mark Le Doux explained that the waiver was for properties that had delinquent taxes for the 2012 tax year. The waiver would relieve the Town of taking ownership of the properties.

D. Petry wondered if any of the property owners have come forward to discuss a payment plan. T. Brown stated that he is aware of one property owner that has initiated the conversation of a payment plan. The Board discussed the delinquent taxes on these properties.

There were thirteen individual deed waivers that totaled \$37,114.02. T. Brown explained that if the Board does not vote to sign the tax deed waivers, the Tax Collector will take the property by tax deed. The Board recommended that the property owners contact the Tax Collector to work out an agreement to pay the taxes.

MOVED by Frank Cadwell, seconded by Peter Band, that the Selectman sign the tax deed waivers. Notices will be mailed to the individual property owner(s) to request that they contact the Tax Collector to create and implement a payment plan for any delinquent property taxes. Voting in favor of the motion were Le Doux, Petry, Band, Cadwell and Manoukian. No one was opposed. The motion PASSED 5-0-0.

10. Committee Reports

Hollis Brookline Cooperative School Board: Maryanne Shanley reported that Krista Whalen is the new chair. Elizabeth Brown is the vice-chair and Eric Pauer is the secretary. The Cooperative School Board is continuing their work on a curriculum committee. They had a New England Association of Schools and Colleges (NEASC) evaluation last month that went well and the Board will have a draft report available over the summer.

The Board of Selectmen discussed the make-up of the NEASC Committee. The NEASC evaluation is voluntary but costs about \$8,000.00. The Board asked why Hollis participates if it is voluntary. M. Shanley felt it is an external audit to rank the Cooperative against other schools in New England. It is a more objective assessment. M. Le Doux asked if there is another type of assessment done by the Department of Education. M. Shanley stated yes and the Cooperative far exceeds their standards. The Board discussed the space issues at the School that negatively impacted the NEASC review in the past.

11. New Business Matters

Synthetic Cannabis (Spice): V. Manoukian stated that ten days ago there was a drug bust in Goffstown, NH where millions of dollars in spice was seized. V. Manoukian would like to re pursue adoption of an ordinance so Hollis can enforce the prohibition of spice. M. Le Doux stated that the Board received a letter from Attorney Drescher that specifically stated that the Board does not have the authority to pass a statute.

M. Le Doux asked the Town Administrator to contact Senator Kevin Avard and coordinate a meeting for the Board of Selectmen to discuss the matter. V. Manoukian stated that the Mayor of Manchester closed businesses for selling spice. He asked if the Town Administrator would find out how Manchester had the authority. He believes they passed an ordinance similar to the ordinance that he would like to adopt in Hollis.

M. Le Doux requested that the Town Administrator draft and send a memo to Attorney General Joseph Foster asking why Hollis can't pass an ordinance prohibiting synthetic cannabis. M. Le Doux asked the Town Administrator to copy the Board of Selectmen on all of the correspondence requested above.

Capital Lease Agreement: Earlier in the day, Mark Le Doux executed a 2.89% capital lease agreement with Tax Exempt Leasing Corporation for three years for the replacement police cruisers. It is the standardized lease program and the town purchases the vehicles at the end of the lease for \$1.00.

Rick Towne, Fire Chief, recently received three titles for fire vehicle at the cost of \$1.00. The vehicles will be in service for another 10 years.

M. Le Doux thanked the Board for supporting the lease purchase program a few years ago as it has proven to be a very cost effective solution. He also thanked very competent town staff.
