NEW / OLD BUSINESS

1. Street Names

a Win

a. Winnies Way (Common Way on Pepperell Road, Route 122)

Becky Crowther stated that the common driveway is owned by Thomas and Kimberly Lawlor. Previously it was owned by William and Winifred Hall and prior to that is was owned by George Hills. B. Crowther recommended the name Winnies Way after Winifred Hall, who was Mrs. Lawlor's grandmother.

MOVED by David Petry seconded by Paul Armstrong that the Selectmen approve the request to name the common way on Pepperell Road, Route 122, Winnies Way. Voting in favor of the motion were Le Doux, Petry, Band, Cadwell and Armstrong. No one was opposed. The motion PASSED 5-0-0.

b. Filomenas Way (Common Way on Proctor Hill Road)

Becky Crowther stated that the common driveway is currently owned by Steve Rheaume. It is a three lot subdivision. Filomena DiCicco was a registered nurse and purchased the land from the Worcester brothers in 1946.

MOVED by David Petry, seconded by Paul Armstrong that the Selectmen approve the request to name the common way on Proctor Hill Road, Filomenas Way. Voting in favor of the motion were Le Doux, Petry, Cadwell, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

2. Employment (Finance Officer)

a. Rachael Gosselin, effective 3/6/19

MOVED by Paul Armstrong, seconded by Peter Band that the Selectmen ratify the action previously taken to extend an employment offer to Rachael Gosselin for the Finance Officer position, with an effective date of 3/6/19. Voting in favor of the motion were Le Doux, Petry, Cadwell, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

3. Proposed Warrant Article 17 – Subdivision of Homestead Structure and Lot

ARTICLE 17 - Subdivision of Homestead Structure and Lot

To see if the Town will authorize the Board of Selectmen to take all necessary steps to survey and obtain applicable authorization from the Town of Hollis Planning Board to subdivide the Stefanowicz property, acquired by the Town pursuant to authorization given by the passage of Article 4 at the March 12th, 2016 annual meeting. The authorization to subdivide shall be limited to creating a lot not to exceed five (5) acres (the 'house lot') which would include the existing homestead and appurtenant structures in order to facilitate the sale of said homestead

structure and lot and to further authorize the Board to take all steps necessary to enter into any agreements and execute any documents necessary to carry out said sale on such terms and conditions as the Board of Selectmen, in their sole judgment, determine.

The town intends to obtain invitations to bid for the property, and will publicize accordingly. The 2019 property assessment is estimated to be \$313,600.

The language in the proposed warrant article states, "The authorization to subdivide shall be limited to creating a lot not to exceed five (5) acres..." It was suggested that the Selectmen include this language so the town could take all of the out buildings into consideration. The actual lot size may be more like 3.1 acres with an easement. The board does not contemplate two lots, just one. The intent is to package the property as a single family residence, not to be further subdivided.

The area to the south of the house includes both the well and the septic system area along with some wetlands that were not to be part of the lease area. Since the well and septic are in this part of the lot, the Selectmen wanted to ensure adequate acreage was included in the language for the warrant article, for easement purposes.
