□ The Meeting Minutes from 7 Jan 2019 were approved.

- Town Administrator started today. She will be invited to the HEC future meetings.
- Green House project updates

Erin has received \$2,600 in funding and is ready to put together a plan for a solar demonstrator project in the greenhouse. Expecting a 6 panel single pole grid connected demonstrator. Woody has a BOM for the system and sent it to Erin. JW might be able to donate some scratch & dent from his employer QCells.

6 60 cell panels ~300W with microinverters.

DPW Pole Mount is the mount for the panels which then goes on an 8" schedule 40 pipe.

Eitan is meeting with Erin tomorrow to discuss how it will work.

Adam estimated that 9 panels would be able to keep a 15x15 section of the greenhouse above 50F. A small heat pump should be sufficient but cost less than \$10K. 6 panels would be comfortable amount sun.

Eric is still working on the sensors which he demonstrated. The battery life is still far too short but he will be working on it this week/weekend.

Street Light Upgrade

Todd was not in attendance. Todd distributed the RFP which will go out later in the spring.

Energy Portfolio

The problem is that the government shutdown includes the Energystar.gov web site so we can't get at any of our data until the funding is back on. All the buildings in but there now holes in the data. Eric is working on closing the holes.

- Eric is working with Dick Henry to begin the detailed power analysis on HPS which appears to have a problem with the Net Meter as no power is being used inside the building.
- Feb 27th is scheduled to have the electrician install the energy meters on HUES. The building has to be shut off during the install. Paul has a 24 channel CT sensor to narrow the source of the demand changes.

- Woody has not contacted the Fire Chief yet to review the 2012 energy audit and solar panels for the roof
