### **Solar Array at HBHS**

The High school has a roughly 3 acre cleared field on the other side of the new turf field that would be ideal for a solar array.

#### **Street Light Project:**

Only 1 of the 3 Library Parking lot street lights have been changed. Joan spoke to Affinity and they are looking into it.

We only have 1 lamp on site. Eversource is moving some poles at the library. Waiting to hear more details later this week.

Are the rec field lights LEDs?

#### **Municipal Buildings Energy Review:**

Eric has been working with George Samaras at Eversource to get more detailed data on energy use at the GV rated accounts (schools) so we can better analyze usage and reduce costs.

**Town Hall** - Need to get the Eversource 30min data and compare it with the Emporia data to find the Demand Charge high point. **HBHS** - The BMS system is at end of life and the required upgrade will cost \$16k. We will continue to discuss with the SAU. Eric explained how an upgraded BMS system will be a significant help in controlling electrical costs. 32% of the current monthly bill is driven by demand costs.

**HBMS** - The eGauge ordered and will be here soon.

Eitan will schedule a time to learn how to download the greenhouse sensor data.

**HPS** - EverSource will unlock the CT panel on Thurs. or Friday (9/3-4). Eric will coordinate hook up of the e-gauge after that. Paul and Eric will work together with the SAU to plan for the changes to the BMS system.

HUES - Various HSMART activities are ongoing but slow due to school opening next week.

**Transfer Station** – Joan needs an upgrade of the lighting. This is mostly a DPW project to upgrade. The HEC naturally recommends LEDs. Eitan will help out.
