#### **HBMS EGauge Installation:**

Eric explained that an investigation of the HBMS panel by an electrician discovered that the wires are too big for the eGauge clamps we have and bigger ones will have to be procured. Also, due to the high power on the lines and cramped spacing the building power will have to be shut off while the bigger clamps are installed. Eric will coordinate this with the SAU office.

### **Municipal Buildings Energy Review:**

Eric feels that we have sufficient data from multiple town buildings to begin analysis and 'treasure hunts' looking for ways to reduce energy use. Specific activities will be identified in future meetings.
