Approved with changes – motion by Honi; 2nd by Jan.

Business: The Hollis Selectmen's Breakfast for Volunteers will be Saturday, March 2, 9 – 10:30am.

Our Woodmont storage issue is moving along thanks to Paul, who spoke with Adrian and others who are necessary to the process. We will have the trailer emptied, and moved while the ground is still frozen.

Signage for Woodmont: Karla and Wendy went to Classic Signs, and learned from George Gagnon about the signage materials that they use. They expect their outdoor signs to have a life of at least 10 years, and they do treat them with UV protection. The cost to us would be just \$175 per sign – which will allow us to have all the signs done, and also pay to have them properly installed. Honi moved that we go forward with Classic Signs; Jan 2nd.

Presenting the exact signage and locations to the Selectmen will be the next step; it is planned that we'll do that at their March 25 meeting.

Karla has very kindly allowed us to use her flash drive for the Woodmont information, and Jan has also used her own flash drive for the HHC financial information – Wendy brought up that we really should have some flash drives dedicated to HHC business. Aurelia moved that we buy some; Karla 2nd, and Karla will look into purchasing them.

Spring Drive-It Day: We are looking at the weekend of June 22, Saturday. Everybody please check to see if you'll be free that day & let Wendy know ASAP. Our second choice will be June 29. One possibility for our drive would be to the Delaney Clock Shop in Townsend – the proprietors have already volunteered to give us a tour & talk.

Calendar: Karla has advertised extensively for photographs for the 2020 Calendar. The theme is to be Scenic Hollis.

Inventory of HHC property, as discussed last month: Karla has gone through the cabinet drawers in the Town Hall, begun organizing the cabinet, and put together an excellent list of existing inventory.

Wendy and Honi recorded a barn that burned, for a demolition survey: 23 Proctor Hill Road.

Michael reports from the Historic District Commission that it's been a relatively quiet month; at 28 Proctor Hill they're interested in re-building. Additionally, the Congregational Church is planning some landscaping, possibly moving the stone wall next to the graveyard: it all remains to be seen.
