Looking for a new place to hold football practice. Last season held practice at CSDA but the school has made that location financially too expensive to continue to use. The teams are approximately 60% Hollis and 40% Brookline participation. Would like to use the Hollis fields for this coming season which runs the end of July through October. Summer practice would be Monday - Thursday, September and October would be 3 practice days from 6-8pm. Discussed options. Will find some field space to make it work. Kyle will check schedules with other fall teams and add football to the available spaces.

Need to move the flag pole and add light post. Kyle will get estimates for both moving the flag pole vs. a new flag pole. Dave will get estimates for lights and pole. Frank will notify the selectmen.

Dave would like to investigate 2 basketball courts with lights. Would like to begin inquiry for behind the Farley building as a location. Will also talk to adult basketball group.

Field options for a future HBMS lacrosse team put on hold until the school forms a team.

Fields: Do we want to move forward? Paul Miller brought a list of locations to be considered for field locations. Discussion regarding 2 fields and locations led to having the board review the list. Will come to the May meeting with 3 or 4 locations that would be feasible for fields and begin discussions and planning again.
