MOTION by Jake Balfour to approve the minutes dated 11/17/22, 2nd by
Russ Rogers APPROVED

Playground: Quotes are in for the proposed playground that will be set up
behind the Hollis Social Library. Three different companies have sent
quotes. The price includes the design fee.

Miracle- will take six months to come in. Same company that set up the
HPS playground. Warranty is lifetime. Company will do safety inspection
at any time for \$400.00

Landscape Structures- six to twelve weeks to come in. This company did
Robey Park in Nashua. Warranty is twenty five to thirty years. This
company is in Merrimack NH.

Playgrounds by Leathers- three to four months to come in. This company
did the Twin Bridges playground.

Need to figure out budget for play structure and surfacing. Some money
will come from the rec. budget and will need additional money from the
town.

MOTION by Russ Rogers to ask the selectboard for \$100,000.00 to
purchase, ship and install a new play structure for Little Nichols with
\$30,000.00 from the rec. committee for turf to cover the ground under the
play structure. 2nd by Jake Balfour APPROVED

Discussed the possibility of a fence to run along the edge of the parking lot
behind the church and the library.

Softball: Suggested raising fee's from \$95.00 to \$115.00. This will help to
cover the cost of renting the YMCA. The pitching machine needs to be
repaired. Registration opens 12/16/22 and will close in February of 2023.

Need to build official softball rosters. There will be a softball meeting in January. Coaches will need background checks. Erica will talk to HPD.
