PUBLIC HEARING

Adoption of RSA 40:13 (SB2)

Chairman Petry stated that there was a petition warrant article for SB2, submitted by a resident, for the annual Town Meeting. The Select Board is required to hold a public hearing prior to the Town Meeting vote, pursuant to RSA 40:14. The Select Board will take no action, following the public hearing. Residents will have another opportunity to speak on the petition warrant article at Town Meeting on May 15, 2021. Chairman Petry recited the rules of the public hearing.

Doug Davidson (Rideout Rd) submitted the petition warrant article and was asked by the Board to make a brief presentation before receiving public comments. D. Davidson stated that is was a matter of voter rights as it relates to disenfranchised voters as they cannot attend a traditional town meeting. Additionally, the multi-hour traditional meeting format meant many voters won't show up to debate warrant articles and vote on all topics in one session. He felt that ballot voting removed any type of intimidation and provides a deliberative session several weeks in advance that gives voters time to educate themselves on important topics on the warrant. The process for SB2 was further explained where the warrant articles and budget are created in the 1st session or "deliberative session" and the voting is finalized via ballot on voting day during the 2nd session. There are over 73 towns in New Hampshire that adopted SB2.

Rep. Jim Belanger (Plain Rd) stated the town has been talking about SB2 since approximately 2006. J. Belanger spoke about the differences between a "traditional town" and a "SB2 town" and is in opposition of SB2, stating that SB2 communities are often guided by those who have strong opposition and seek to vote down select initiatives, where traditional town meeting allows for more opinions to be heard.

Karen Bridgeo (Buttonwood Dr) spoke in opposition of SB2, stating that 71 out of 221 towns in New Hampshire have SB2, which is only 32% of the towns in New Hampshire with SB2.

Sue Homola (Mendelssohn Dr) spoke in support of SB2, stating that she recently sat through a nine-hour school district meeting where about 450 voters decided the fate of the warrant, which is not represented democracy. She felt people are not able to attend lengthy meetings, because they may not physically able to attend all day or they may not be able to drive at night, or may have young families. With the option of the Zoom platform, the

town can offer deliberation to more people who would not be able to attend the meeting, otherwise. She felt that just because people do not attend a deliberative session, does not mean they are uninformed voters.

Peggy Gilmour (Depot Rd) spoke in opposition of SB2. Of the 221 towns in NH, with approximately 73 with SB2, approximately 45% of those towns have tried to reverse the SB2 status. She represented SB2 towns in the past and witnessed a very small group of people make a significant change in the budget, which was very detrimental to that town.

Michelle St. John (Orchard Dr) spoke in opposition of SB2, stating that under the SB2 format, if a voter misses the deliberative session, there is no opportunity to make a change to a warrant article. Adding that residents are ultimately voting on whatever the majority of people who attend the deliberative session prefer. Until the town changes the form of government to a town council format, the deliberative session is a way for individuals to be involved.

Maureen Maisttison (Milton Pl) spoke in opposition of SB2 and felt SB2 was a bad Band-Aid for an antiquated system of government and would prefer another alternative, such as town council form of government.

Tracy Clifton (Federal Hill Rd) spoke in opposition of SB2 and will hold out for a town council form of government.

Rep. Kat McGhee (Hayden Rd) spoke in opposition of SB2, stating that a deliberative session cannot adequately replace a traditional town meeting. Adding, that there is often little discussion at deliberative session and it is not the same as a town meeting.

Eric Pauer (West View Rd, Brookline) spoke in support of SB2, adding that SB2 has been in place for the Brookline school district for about five years with a lot of participation. Although Brookline had the same number of participants at its deliberative sessions compared to town meetings, the number of voters was more than 10 times the amount who actually vote, which he considers democracy in action. More people are voting, more people are participating and more people are being heard. He felt over all, you get more participation with SB2.

With no further comments the public hearing was closed at 7:06PM.

RESIGNATION

Cheryl Quaine, Conservation Commission, effective April 21, 2021. On behalf of the Select Board, Chairman Petry thanked Cheryl for her service to the community.

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board approve the resignation of Cheryl Quaine, Conservation Commission, and effective April 21, 2021. Voting in favor of the motion were Petry, Benz, Band and Armstrong. No one was opposed. The motion PASSED 4-0-0.

NEW BUSINESS

Department of Public Works (Joan Cudworth, Director)

Reclaimed material at Stump Dump

Joan Cudworth, DPW Director reported that they are not having much luck trying to sell the reclaimed material. Therefore, it was recommended that DPW hire New England Mobile Crushing to crush the material on-site. Moving forward, the Transfer Station will no longer accept reclaimed material from commercial vendors at the Transfer Station. They will continue to accept the material from residents. J.

Cudworth will notify abutters of the Transfer Station to let them know about the material crushing, as the process is very loud and may take up to six days to complete. The total cost will be approximately \$42,000.

Millyard Bank Paper Shred Day

The town received a request from Millyard Bank to have a paper shred day at the Transfer Station. There is no cost to the town for the event. Once the date is determined, the event will be publicized.

Hollis Energy Committee (Venu Rao) – Electric School Bus Presentation

Venu Rao made a presentation on a Feasibility Study to convert diesel school buses to electric school buses. The Nashua Regional Planning Commission (NRPC) Executive Committee established a subcommittee to explore the possibilities of replacing current school buses with electric school buses. Hollis Energy Committee (HEC) is also participating in the study and will collaborate with NRPC subcommittee. The presentation was informative and reviewed the benefits of electric buses. Although the school buses for Hollis are contracted to an outside agency, the other purpose of the presentation was to inform the Select Board of what the NRPC is working on as both Venu Rao and Bob Larmouth are Hollis representatives on the commission. The next step is to bring the stakeholders together and put together a plan. The Select Board applauded the group's efforts and thanked Mr. Rao for the information. The board expressed interest in learning more about electric vehicles for DPW, Police and Fire. V. Rao will provide updates to the board as the project progresses.
