# **APPOINTMENT**

1. Heritage Commission – Cassandra Vorisek-Creto, Alternate Member, (term exp. 04/30/2022)

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board appoint Cassandra VorisekCreto as an Alternate Member to the Heritage Commission, with a term expiration date of 04/30/2022, as
recommended by Chair, Wendy Trimble. Voting in favor of the motion were Petry, Le Doux, Benz, Band

and Armstrong. No one was opposed. The motion PASSED 5-0-0.

### **NEW BUSINESS**

1. Town Meeting Update

Drew Mason, Town Moderator thanked the Board for changing the start time for the annual meeting to 9:00AM on May 15<sup>th</sup>. D. Mason is anticipating approximately 400 residents in attendance. The meeting script, including timeframes was reviewed. The weather and alternate date and locations were discussed, however, it is anticipated that the meeting will go on as planned, under the tent at the lacrosse field. It was noted that voting for the petition warrant for SB2 must be open for an hour and voted on by secret ballot.

## 2. Highway Safety Committee (HSC) Recommendations

# a. Stop Sign at intersection of Ames Road & Witches Spring Road

 Chief Towne stated that the bus company requested the stop sign. The HSC voted on the request and recommend the installation of the stop sign to the Select Board.

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board approve the installation of a stop sign at the intersection of Ames Road and Witches Spring Road. Voting in favor of the motion were Petry, Le Doux, Benz, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

## b. Redesign the intersection of Broad Street & Wright Road

 HSC recommended that DPW Director assess the area and provide design options to the Select Board. It was reported that the state is willing to work with the town on a solution. J. Cudworth was directed by the Select Board to look into solutions for the intersection.

## 3. Recommendation to discontinue fire easement on Beaver Brook property

Chief Towne explained that the fire easement is located on West Hollis Road near the Nissitissit River. In 1981 the Fire Department asked Beaver Brook for an easement with the intention that a road would be installed so the fire trucks could access the water. The road was installed, however there had been erosion problems and the Fire Department no longer needed access to the water from that road since they could draft the water from the bridge area or the hydrant that is in close proximity. Chief Towne stated that there is no longer a need for the easement. Additionally, Beaver Brook offered to pay any recording fees for the easement.

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board approve the recommendation from Chief Towne to discontinue the fire easement on Beaver Brook property. Voting in favor of the motion were Petry, Le Doux, Benz, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

## 4. Farley Building Update – Transfer funds from Contingency to Special Studies

The committee is working towards solidifying options and costs for the facility. When the preliminary assessment is complete, it will become a part of the application that is sent to New Hampshire Preservation Alliance. The New Hampshire Preservation Alliance could help pay for the costs associated with the second phase. In order to pay for the first phase or pre-application, the committee will need some funding. Funds could be transferred from the Contingency Fund to the Special Studies Fund.

MOVED by Peter Band seconded by Mark Le Doux that the Select Board approve transferring \$10,000 from Contingency to Special Studies for costs associated with the Farley Building assessment/application. Voting in favor of the motion were Petry, Le Doux, Benz, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

P. Band added that the thought the building was becoming quite the eye soar and suggested the board consider painting at least the front of the building in the meantime. D. Petry suggested including costs for painting in next year's budget, unless there are funds in the current DPW department.

## 5. Delegation of Functions (Finance Director)

Pursuant to the provisions of RSA 41:29, functions including deposit, investment, recordkeeping and reconciliation functions for the Town of Hollis shall be delegated to Jacob Fitzgerald, Finance Director, as recommended by Barbara Townsend, Treasurer for the Town of Hollis.

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board approve the Delegation of Functions to Jacob Fitzgerald, Finance Director, as recommended by Barbara Townsend, Treasurer. Voting in favor of the motion were Petry, Le Doux, Benz, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.

# 6. Contract Approval – Attorney John Ratigan (Ratify approval via email on May 3, 2021)

It was stated that the contract for Attorney Ratigan pertains to one particular court case for the Town of Hollis.

MOVED by Paul Armstrong seconded by Susan Benz that the Select Board ratify the approval previously taken via email on May 3, 2021 to approve the contract for legal services with Attorney John Ratigan. Voting in favor of the motion were Petry, Le Doux, Benz, Band and Armstrong. No one was opposed. The motion PASSED 5-0-0.
