#### 11 PLEDGE OF ALLEGIANCE

12 The Pledge of Allegiance was recited.

### 14 **PUBLIC HEARING**

At 6:32PM Chairman Le Doux opened the Public Hearing of the Hollis Select Board, pursuant to RSA 40:14 to
 consider petition warrant article asking voters of the Town to adopt the provisions of RSA 40:13 (Senate Bill 2 SB2).

18

19 Doug Davidson (Rideout Road) made a presentation in support of SB2. The slideshow presentation can be viewed 20 through Meeting Videos, at the town website at www.hollisnh.org. Overall, he felt the SB2 process eliminates the 21 extremely lengthy meetings and avoids the suppression of the voters that are not able to spend the duration of the 22 meeting at Town Meeting. SB2 is a two-step process where the first step, the Deliberative Session, similar to Town 23 Meeting with the Town Moderator, is where all warrant articles are created, discussed, amended and published 24 leading to a finalized list of warrants. The second step is where warrant articles are voted on via ballots during an 25 all-day voting scenario. He felt SB2 greatly eases the burden and responsibility to participate, resulting in greater 26 voter participation, keeping the benefits of a Town Meeting, with no more extraordinary energy required, and to 27 become informed and vote.

Tom Dufresne (Pound Road) spoke against SB2, stating that since Town Meeting has been on Saturday, he doesn't recall having the meeting last longer than 6 hours and didn't feel it was a burden. He didn't feel any more people would attend the deliberative session than town meeting as it is now. He was concerned with misinformation that could be distributed via social media and felt town meeting requires people to attend the meeting in person to hear the discussion first hand.

- Jim Belanger (Plain Road) spoke against SB2, stating that ballot votes are only yes or no votes. He felt the process eliminates the opportunity to modify or amend a vote. What is on the ballot on Election Day was already decided on at the deliberative session. He felt the same participation issues would occur for the deliberative session than town meeting. If the budget fails at the polls, the town has to utilize the default budget. The default budget can be padded and covers certain issues the town may want. He suggested pursuing a Charter Town process oppose to SB2.

Doug Davidson (Rideout Road) reiterated that the comments made by the prior to residents, were the typical
 objections to SB2. Approximately 70 towns, including the Town of Brookline currently use SB2.

45 Peggy Gilmour (Depot Road) spoke against SB2, stating that a town can have a low turnout at the deliberative 46 session where few people could make significant changes to the ballot. She stated that it is concerning to have a 47 small group make such a significant change in the way the town functions.

Carol Roy (South Merrimack Road) spoke against SB2 stating that although she understands the difficultly with attending town meeting, she didn't feel that anyone would be more informed by the deliberative session process than by town meeting. Her concern was that some people will attend the deliberative session, some will attend the voting and will not be any more informed than had the attended a traditional town meeting, where all articles are explained. The ballot does not come with a full explanation of every article. Although SB2 would be convenient, it would not provide the result that we all want. She suggested exploring the option of utilizing groups/organizations to provide childcare to help with attendance at town meeting.

- 57 With no further discussion, the public hearing was closed at 6:54PM.58

M. Le Doux explained that the town changed town meeting from the evening to a Saturday to accommodate the community in order to obtain as much inclusion as possible for the voters. The overall consensus from the Select Board was not in favor of SB2. The budget cycle begins in the fall and many meetings are held and posted in order to provide information to the community. Town meeting brings people together to work through the issues and to interact with each other in order to come to a consensus.

M. Le Doux stated that the board received a lot of feedback on the proposed petition warrant articles. Although he was under the impression that both article 17 (*Petition Article for Proposing Bylaw*) and article 19 (*Petition Article for Preservation and Protection of "Passive" Uses on Town Own or Steward Properties*) were advisory in nature, that is in fact not the case. Following consultation with legal counsel, article 17 is not advisory, but mandatory. After discovering this information, M. Le Doux asked the Board for permission to publish the legal analysis from Attorney Drescher, so residents have an opportunity to review and process the information, prior to town meeting.

- MOVED by Peter Band seconded by Mark Le Doux that the Select Board approve releasing and publishing the
   legal opinion for petition warrant article 17 to the town website. Voting in favor of the motion were Le Doux, Petry,
   Benz, Band and Cadwell. No one was opposed. The motion PASSED 5-0-0.
- Doug Arseneau (resident, address not given) spoke from the audience, questioning why the information is being
   released three weeks before town meeting, which he felt was not sufficient time. He questioned by the information
   wasn't provided with the budget, in the fall.
- M. Le Doux explained that petition warrant articles were due February 4<sup>th</sup>, so this is the first meeting since the
   Board received the legal opinion and wanted to share it with the community as soon as possible. It will be posted
   the following day, which is approximately three weeks before town meeting. The opinion will also be posted at
   town meeting.
- M. Le Doux added that since the interest rates are the lowest they've been in 60 years at 1.396% on 10 year bonds,
   the town should consider refinancing all outstanding bonds for the town.
- Boug Davidson (Rideout Road) requested that the Select Board send a letter to the Hollis Brookline Cooperative
   School District encouraging them to consider refinancing their bonds as well.

portion of the program. A former Hollis resident spoke about his experience with the program. They are asking

- each of the towns within the county for \$5,000 to assist with the program.

Lori Radke, Town Administrator explained the process for budget requests for agencies, such as this. The
Board agreed to use \$5,000 from the contingency fund for this program.
